C I R C U L A R 39 ✓

It has been noticed that notorious dacoits or their associates, on arrest, are not generally properly and exhaustively interrogated. The statements are cursory and there is lack of interest on the part of investigating officer in interrogating the accused. The interrogation of such accused is most important and very useful for detection purposes, to unearth undetected cases to trace out other associates and harbourers and to apprehend the accused at large. Therefore, the outlines of the relevent points upon which the interrogation of such accused and dacoits should be made is given below for the guidance of all concerned. It is hoped that ~~greater interest shall be evenced~~ and the instructions laid down in the circular are strictly adhered to.

1. Accused's own history and that of his family, friends and other relatives with their full addresses and occupation.
2. His and his associate's education, character and other habits.
3. The reasons and circumstances under which he resorted to crime.
4. The date, month and the year when he committed his first crime with full details of the crime, associates and property.
5. The date, month and the year when he first met any criminal along with the name and other particulars of such persons and if possible the brief of their conversation.
6. His place of shelter and harbours in the earlier stage.

7. The details of subsequent crimes committed before absconding.

8. The date, month and year when he absconded along with the details of any arms, conveyance or companion taken with him at the time of absconding.

9. Total number and nature of crimes he committed after absconding. The names and description of his associates and the gangs he joined along with the marks of identification of the members of such gangs with their alias and full history.

10. Names of the harbourers and sympathisers, places of shelter, hideouts, rendezvous and the routes taken by them before and after the commission of the crimes.

11. The places and persons through whom and where stolen property was disposed off along with the names of the receivers.

12. The places and persons from where they used to get arms and ammunition along with such other sources from where the arms and ammunition were procured and obtained.

13. ~~13.~~ Facts and modus-operandi of the crimes committed.

14. The ~~name~~ description of the arms used by him and his associates.

15. The names of material P.Ws whom the accused remembers or with whom the accused came in contact.

16. Thorough interrogation regarding the stolen property, its recovery and other relevant related facts.

17. The description of conveyance often used and the uniforms put on, at the time of committing the crime.

18. Specific question about particular offences and offenders.

19. Any important matter if he remembers out of usual conversation between outlaws about any important crime and notorious dacoit, which may lead to some discovery in any case or may disclose the future programme or
