

STANDING ORDER NO. 1  
Sulu's Corruption cases, No. 1.  
The Government under notification No. F.11/1/4/14/57

1. 13.7.57, have declared the office of the Special Inspector General of Police, Anti-Corruption Department, Rajasthan at Jaipur to be an Anti-Corruption Police Station with territorial jurisdiction extending over the entire State of Rajasthan.

2. According to prevalent practice the Supts. of Police I/O Districts after registration of the cases of corruption, bribery and misconduct on the part of Govt. servants request the Dy. Supt. of Police, Anti-Corruption Department to take over investigation of those cases which are against the aforesaid Govt. order.

The following instructions are therefore issued for guidance of ~~the~~ <sup>all</sup> concerned:-

- (i) The intention of the Govt. by issuing the notification under reference is to restrict investigation in cognisable offences enumerated therein to the officers I/O of the Anti Corruption Police Station at Jaipur. The officers of the Anti-Corruption will therefore investigate only the cases registered at the Anti Corruption Department, Police Station at Jaipur. Cognisable offences relating to bribery and corruption including criminal breach of trust, criminal misappropriation and criminal misconduct in which a public servant is involved are to be taken cognisable of by the Anti Corruption Police Station only.
- (ii) The local police who have been divested of this power and have no concurrent jurisdiction over such cases will hence forth deal with the cases registered against persons other than Govt. servants within the limits of their Police Stations only.
- (iii) If any person approaches the local police with the report of commission of any such offences it is the duty

of the Station House Officer and other senior person concerned to report the offenses to the Police Station at Jaipur or at one of the regist set up by the Spl. Inspector General of Police Department from where the complaint will be to Anti Corruption Police Station at Jaipur for further investigation.
