STANDING ORDER No.2

In order to facilitate action on correspondence received from the Vigilance Commission, a separate Vigilance Cell has been created, which will function under the Additional S.P. (Complaints), C.I.D. Crime Branch. The Dy.I.G.P., C.I.D.(Crime) would exercise over all supervision ~~on the functioning~~ on the functioning of this Cell.

2. It is, therefore, desired that all correspondence received from the Vigilance Commission should be sent to the Addl.S.P. (Complaints) for further necessary action. Similarly, the compliance of any orders issued in connection with the - correspondence received from the Vigilance Commission will also be done by the Addl. S.P. (Complaints).

3. The Addl.S.P. (Complaints) will ensure expeditious disposal of all preliminary enquiries desired by the Vigilance Commission. He will also follow each case to final disposal in case a D.E. or criminal action is initiated as a result of these preliminary enquiries.

4. To avoid any duplication of work all files now being maintained in any other Branch of the P.H.Q relating to - references by the Vigilance Commission should be immediately transferred to the Addl.S.P. (Complaints).

5. Since misconduct reports are also a part of complaints, they will also be dealt with by the Addl.S.P. (Complaints). The A.I.G(II) will make necessary arrangements for transferring the same to the Addl. S.P.(Complaints). The concerned clerk of the Force Branch should also be placed at the disposal of the Addl. S.P.(Complaints).

6. The Addl. S.P. (Complaints) will also ensure that the periodical returns required to be sent to the Vigilance Commission are henceforth sent at the proper intervals.

7. The Addl.S.P. (Complaints) may request the District S of Police to conduct the preliminary enquiries and the Distr Ss.P. should ensure that such enquiries are conducted properly and promptly. The District Ss.P. will be personally responsible that the reports sent after preliminary enquiry are complete and comprehensive and that full care has been taken to avoid any unnecessary correspondence thereafter.

8. It has also been observed that D.Es initiated as a result of recommendations of the Rajasthan Vigilance Commission have been abnormally delayed. It is enjoined upon all disciplinary authorities that positive steps be taken to ensure expeditious disposal of all such D.Es pending with them and that in future such delays are avoided. The tendency of permitting enquiry Officers to take their own time in completing the D.E is not desirable and in future the Addl. S.P. (Complaints) will be required to put up cases where abnormal delay is detected for further necessary action.

9. The Vigilance Cell will initially be provided with 1 U 2 L.D.Cs and 1 Steno Typist. The D.I.G. CID will provide 1 U.D and the A.I.G.(II) will put up proposals for providing 2L.D.C and one Steno- Typist.
