

Dated the 1st March, 1975.

The syllabus for different examinations for Qualifying Examination for promotion to higher ranks were prescribed by the following standing orders :-

- i) Standing Order No. 2 dated 8.7.66 for promotion from the rank of H.C. to the rank of ASI(CP)
- ii) Standing Order No. 1 dated 6th June, 1974 in supersession to earlier Standing Order No. 4 dated 19.7.66, for promotion from the rank of S.I.(CP/AP) to the rank of Inspector(CP/AP).
- iii) Standing Order No. 7 dated 26.7.66 for promotion from the rank of Constables (CP/AP/MT) to the rank of H.C.(CP/AP/MT).
- iv) Standing Order No. 9 dated 17.8.66 for promotion from the rank of -
 - a) H.C. and ASIs(CP) to the rank of SI(CP)
 - b) H.C. (M.T.) to the rank of SI (M.T.)
 - c) H.C. (A.P.) to the rank of S.I.(AP)

The above standing orders in force for Qualifying Examinations are prescribed respectively for the concerned rank as syllabus for Part I and Part II Qualifying Examination for promotion to the concerned rank under Rule 26(2) of the Rajasthan Police Sub-ordinate Service Rules, 1974.

2. Standing Order No. 3 dated 12.2.75 issued by the IGP wide No.P.7(4)DIG-Trg/75/233 dated 12.2.75 is already prescribed as syllabus for Part (I) examination under Rule 26(2) of the Rajasthan Police Sub-Ordinate Service Rules, 1974.

3. Various orders issued for laying down duration and syllabus for Promotion Cadre Course Examinations of various ranks by the Principal, P.T.C. Kishangarh after approval from Police Headquarters shall be deemed to have been issued according to rule 27(2) of the Rajasthan Police Sub-ordinate Service Rules, 1974.

4. The above order shall be deemed to have been in force from November 28, 1974, the date on which the Rajasthan Police Sub-ordinate Service Rules, 1974 came into effect.
