STANDING ORDER NO. 4/83

This is in supersession of all previous Standing Circular Orders and instructions regarding filling in vacancies by direct recruitment and by promotion in all the training institutions. The strength sanctioned for training institutions and the vacancies normally caused in the training institutions are very meagre and for filling them up Constitution of Board etc. is too cumbersome a process to follow. Completion of the various formalities would also normally cause a vacuum which a training institutions can not afford. Henceforth, the following system shall therefore, be followed for filling the vacancies in various ranks in all the training institutions of the State Police.

1. In so far as the question of direct recruitment is concerned, the concept of a 'Training Range' is abolished. The present practice of making recruitment directly against the posts sanctioned for the training institutions is discontinued forthwith.

2. No promotion tests shall be held for the training institutions exclusively. The practice of clubbing the posts of training institutions with the strength of the Ranges/Units as is being done at present, be discontinued forthwith. The posts sanctioned for the training institutions shall be filled on temure basis from the D.E.F./R.A.C.

3. The temure of service in the training institutions shall normally be of 3 years' duration, extendable by 2 years i.e. a total of 5 years in exceptional cases. Panels of suitable trainers/instructors shall be drawn up and kept on record in the training institutions/ 'A' Branch or Force Branch, so that the replacements necessitated by completion of temure of officers are made without any delay.


STANDING ORDER 4/83.


