STANDING ORDER NO. 1/88.

In supersession of I.G.P's Circular Order No.9/76 issued vide No.P.11(89)DIP/Trg/75/6725-84 dated 7.5.76 and 6/80 issued vide No.P.8(2) Adl.IP/Trg/Genl/80/6854-69 dated 19.8.80 and all other orders relating to reexamination of failures of Initial Training of S.I.s Cadets (C.P/I.B/I.P/...), the following procedure is hereby prescribed vide Rule 37 (a) of the Rajasthan Police Subordinate Service Rules, 1974 for their reexamination:-

1. If a S.I. Cadet fails in one or two subjects whether Indoor or Outdoor or both, he/she shall be retained at the training institution for a period of two months from the date of declaration of the result and reexamined by a Board to be constituted by the Special I.G. of Police (Training) in the subjects only in which he/she has failed. His/her final result shall be prepared on the basis of earlier examination and submitted to the Special I.G. of Police (Training) for approval. In case he/she fails to pass the examination in the second chance, the candidate shall be referred to the appointing authority for being discharged from service for failing to avail opportunities for becoming efficient member of the Force.

2. If a S.I. Cadet fails in more than two subjects or in aggregate, he/she shall be retained at the training institution for a period of four months from the date of declaration of the result and subjected to intensive around training. After completion of the training he/she shall be reexamined by the Board to be appointed by the Special I.G. of Police (Training) in all subjects. His/ her final result shall be submitted to the Special I.G. of Police (Training) for approval. In case the S.I. Cadet fails to pass the examination in the second chance he/she shall be referred to the appointing authority for being discharged from service for failing to avail opportunities for becoming efficient member of the Force.

3. There may be cases, in which a S.I. Cadet may pass in all the subjects but fails in the aggregate. Such cases would be rare. In such a case, the S.I. Cadet shall have to be informed of the marks obtained by

him in each paper of Indoor and subjects of Outdoor examinations. It may be left to the option of the candidate whether he/she would like to re-appear in all the subjects ( Indoor & Outdoor ) or would like to appear in 50 % subjects to make -up the aggregate. In case the S. L. Cadet fails to make up the aggregate , he/ she shall be referred to the appointing authority for being discharged from service for failing to avail opportunities for becoming efficient member of Force.
