

THE RAJASTHAN JAIL BAND RULES, 1965

1. **Title and Commencement.**— (1) These rules may be called the *Rajasthan Jail Band Rules, 1965*.

(2) They shall come into force with effect from the date of their publication in the Rajasthan Rajpatra.

2. **Definitions.**— In these rules, unless there, is any thing repugnant in the subject or context :—

(i) 'Government' means the Government of Rajasthan.

(ii) 'Officer Incharge of Band' means the Superintendent of the Jail or in the case of 'B' Class Jail the Deputy Superintendent there of.

3. **Constitution of the Jail Band.**— The Jail band consisting of Brass and of pipe instruments may be maintained at the Head-quarters of the Jail. The personnel of the band will drawn from the convicts with good conduct and confidence. Undertrial prisoners can also be employed on their request provided they can be relied upon. The band will be escorted by a suitable guard in plain clothes.

Band will normally consist of not more than 5 convict officers and 50 convicts. The Band Master will be designated as Band Major and pipe Major respectively.

4. **Allowance to Band Personal.**— 50% of the amount received will be distributed among the sathies them selves and the remaining 50% will be deposited in the Rajasthan Jail Band Fund. The band major and pipe major will get 50 paise more than the other sathies out of 50%.

5. **Uniform.**— The personnel of the Jail Band will normally wear ordinary uniform but when they go on ceremonial occasion or on hire they will wear special uniforms prepared for the occasion.

6. **Performance of duty by Band Man.**— The personnel of the Jail Band shall be required perform their normal duties and will not be exempted there from because of their participation in the Jail Band. They will be given training in their off hours of at such time as deemed proper by the officer incharge of the band. The Officer Incharge of the band may, if deemed necessary exempt all or any personnel of the band from the normal duties.

7. **Hiring of Jail Band.**— The Jail band will be hired by any person for any private function provided (1) the function is not objectionable socially legally and politically :

- (i) Prescribed fee has paid in advance;
- (ii) Band is required for any Government purpose.

8. **Hiring charges for Jail Band.**— (1) The Officer Incharge of the Band shall recover in advance hiring charges for Jail Band at the following rates for being employed at private functions:—

For complete Band of 24 persons :

- (i) Rs. 14600/- for a day of 3 hours.
- (ii) Rs. 13200/- for a day of 2 hours.
- (iii) Rs. 12400/- for a day of 1 hour.

For half Band of 12 persons :

- (i) Rs. 13400/- for a day of 3 hours.
- (ii) Rs. 12400/- for a day of 2 hours.
- (iii) Rs. 11600/- for a day of 1 hour.

Which shall include the time taken by the Band in journey to the place where the Band is required.

For each additional hour the following charges will be paid:—

- (i) For complete Band of 24 persons :
Rs. 50/- per hours.
- (ii) For half band of 12 persons :
Rs. 25/- per body.

२।परिवहन व्यवस्था यदि कारागार का वाहन उपलब्ध होगा तो रुपये 250/- अतिरिक्त वाहन व्यय किराया देय होगा तथा वाहन उपलब्ध न होने पर परिवहन व्यवस्था जेल बैण्ड बुक कराने वाले की जेल बैण्ड को से जाने व वापिस जेल पर छोड़ने की जिम्मेदारी होगी तथा समय की गणना जेल से जाने व जेल पर पुनः आने के समय से होगी।

Provided that the band shall be allowed to remain after fixed hours if the programme for the band is not fixed also where and provided further that the minimum charges shall not be less than Rs. 150/- for full band Rs. 75/- for half band if the band is retained for more than 2 hours upto three hours.

The Officer Incharge of the band may in consultation with the Collector of the District may reduce the rate on the basis of rates prevalent in the District or when there is no marriage season or when the band is required for social and religious functions. The Inspector General of Prisons may also reduce the rate upto 25% if the band is required for religious or social functions or for any ceremonial functions.

(2) The Officer Incharge of the band may also allow band being sent beyond 10 miles from the headquarters provided that he had satisfied himself about safety and security arrangements.

(3) When the band is taken outside the Jail head quarters too transportation and diet charges shall be paid by the person hiring the same and the whole amount on account of these charges shall be paid to the Officer Incharge of the band if satisfied may allow the party to undertake the responsibility upon themselves for their transportation and or diet charges.

9. Jail Band will be made available free of cost for the foundations approved by the Government and those organised by the Jail department.

10. Cancellation of Contracts.— The Officer Incharge of the Jail Band may cancel reservation of the Jail band in the case of any person if the Jail band is required for any function approved by the Government or for Jail function but in such case timely information atleast before twenty four hours shall be given to the person hiring the band as for as periodically and the amount of hiring charges shall be refunded to him in full.

11. Transit charges for the Band.— If a person hires a Jail Band at the Jail Headquarters and the distance is more than half a miles, the person engaging the band shall be required to pay for the transportation charge of the entire party of the band or he will arrange transportation facilities.

12. Income for the hire of Jail Band.— All Income derived by hiring out of the Jail Band shall be credited to the Rajasthan Jail Band Fund immediately on receipt by the Officer Incharge of the Band and adjustments shall be made strictly in accordance with the rules of the Government of Rajasthan Jail Band Fund.

13. Form for hiring the Band.— The person hiring the band will submit an application in the form appended to these rules which will be available on payment of 10 NP.
